INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF CHAIRS WITH ARMREST

1. The Don Honorio Ventura State University through the Fund 05-IGF (Income) for the Fiscal Year 2024 intends to apply the sum of Eight Hundred Thirty-Seven Thousand Five Hundred Pesos Only (P837,500.00) being the ABC to payments under the contract for The Supply and Delivery of Chairs with Armrest (Contract No. 143 - DHVSU 2024). Bids received in excess of the ABC shall be automatically rejected at bid opening.

Select this for lot-procurement:

The DHVSU, through the Fund 05-IGF (Income) for the Fiscal Year 2024 intends to apply the sum of Eight Hundred Thirty-Seven Thousand Five Hundred Pesos Only (P837,500.00) The Supply and Delivery of Chairs with Armrest (Contract No. 143 - DHVSU 2024) being the ABC to payments under the contract for each lot/item. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The DHVSU now invites bids for the above Procurement Project. Delivery of the Services is required within thirty (30) calendar days after receipt of Notice to Proceed (NTP). Bidders should have completed, within the last five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

A complete set of Bidding Documents may be acquired by interested Bidders on Aug. 29, 2024 to Sept. 25, 2024, 8:00 A.M. to 4:00 P.M., and Sept. 26, 2024, 8:00 A.M. to 9:59 A.M. from the BAC Secretariat from the given address and website(s) below and upon payment of non-refundable fee in the amount of One Thousand Pesos Only (P1,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees [specify the manner if it will be presented in person, by facsimile, or through electronic means.]}

[NOTE: For lot procurement, the maximum fee for the Bidding Documents for each lot shall be based on its ABC, in accordance with the Guidelines issued by the GPPB; provided that the total fees for the Bidding Documents of all lots shall not exceed the maximum fee prescribed in the Guidelines for the sum of the ABC of all lots.]

- 6. The DHVSU will hold a Pre-Bid Conference on Sept. 12, 2024 , 10:00 A.M. at the BAC Office, 2nd floor UFC Building, DHVSU, Villa de Bacolor, Pampanga and/or through video conferencing or webcasting via Zoom, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address indicated below. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on Sept. 26, 2024, 10:00 A.M. at the given address below and/or via Zoom. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

- 11.
